"THE PROBLEM OF RESERVOIR-INDUCED EARTHQUAKES"

There can be no question that the filling of some reservoirs has triggered local seismic activity, although debates continue concerning the cause-and-effect relationship of some of the larger events, such as the 1975 Oroville earthquake. Some critical questions are: Can a geologist or seismologist recognize areas where triggered events are particularly likely or unlikely? Can one postulate a reservoir-induced event that is larger than the maximum credible naturallyoccurring event? How likely is surface fault displacement during triggered events? What maximum magnitudes should be assumed for reservoir-induced events? Can the problem be mitigated by controlling the way in which a reservoir is first filled? How can one convince skeptical engineers or dam owners that the problem is real--or is it?

FROM THE CHAIRMAN

The March meeting was held jointly with the AEG Southern California Section and the ASCE Geotechnical Group. Attendees were treated to a very informative discussion of natural disasters, presented by Dr. C. Barry Raleigh, Director of the Lamont-Doherty Geological Observatory. Dr. Raleigh talked about the difficulties of earthquake prediction. He then shifted to predicting the occurrence of El Nino, the disastrous weather phenomenon which has worldwide implications. Finally, he discussed the implications of increasing the ${\rm CO}_{2}$ content of the atmosphere and the possible future effects of the warming trend that it has created. Even if his information is only half correct, it is almost unbelievable to contemplate a three meter rise in sea level due to melting of the polar ice.
