TOPIC

LATE QUATERNARY FAULTING, MALIBU COAST FAULT ZONE, MALIBU, CALIFORNIA

Backhoe trenches excavated across South Winter Mesa, Malibu, California reveal the presence of several faults heretofore unrecognized which potentially impact future urban development in this area. The faults parallel the Malibu Coast fault system, and lie between mapped traces of the Malibu Coast and Puerco Canyon faults. They displace the Tertiary Monterey formation, and two overlying wave-cut platforms 80,000 and 125,000 years old. Regressive marine and prograding continental deposits resting on the platforms are also displaced. One fault disrupts basal sediments about 6,000 years old. Other parallel faults are truncated by pre-Holocene sediments capped by a strongly developed relect paleosol estimated to be 35,000 to 40,000 old. The newly discovered faults display both normal and reverse displacement, with vertical offsets reanging from several to 300 cm. Total offset is generally small, for no individual fault forms a major structural discontinuity, nor gives rise to escarpments or other geomorphic expression. The Winter Mesa faults are probably part of the Malibu Coast fault zone, and are likely secondary features generated in response to nearby large earthquakes. Disparate rupture histories on various fault segments indicate recurring late Quaternary earthquakes in this region extending into Holocene time. Accordingly, reevaluation of fault and earthquake risk may well be warranted for this part of the Malibu Coast fault zone.
