

Dana Point Area Case-History: Sea Cliff Stabilization

Scott Kerwin

TOPIC

Scott Kerwin, Project Engineering Geologist with Moore and Taber, will present a case-history on sea cliff stabilization using long rock anchors. The stabilization project is located in Dana Point, California, between the Quiet Cannon Restaurant and Cove Road. The project included the use of long rock anchors to restrain the upper portion of the slide and to protect the restaurant. Limited access, complex slope geometry and difficult drilling conditions required the use of specialized and innovative techniques for anchor construction. An automatic monitoring system of borehole extensometers was installed beneath the restaurant to provide the warning system required to permit continued operation of the restaurant during repairs.

Jack Eagan will preface Scott's presentation with commentary on the unusual degree of cooperation between all parties related to this project.

SPEAKER November Meeting 1988

Scott Kerwin is a certified engineering geologist and holds a B.S. in Geology from UCLA (1971). Mr. Kerwin has been employed by Moore and Taber since 1975, except for a 2-1/2 year hiatus (1977-79), when he traveled to Australia with a major international construction firm.

Scott's professional work includes landslide assessment, fault hazard evaluation, waste assessment and distress evaluation. Projects Scott has participated in include Klondike Canyon Landslide, evaluation, hydrogeological assessment of solar evaporation ponds at US Borax's Boron facility, LAX Second Level Roadway, and the Santiago Aqueduct Parallel.

NEWS

James Shuttleworth sent an article related to the issue of construction damage in adjacent properties from his neighborhood newspaper "Express 10-6-88" summarized below...

Estimated damage of +\$30,000 occurred to a Los Cerrillos Drive home in West Covina, on August 26, 1988, because a boulder was dislodged from a slope during grading operations. The boulder, estimated to weigh a ton and a half, landed in the home owner's bed, which was occupied a few minutes earlier by the owner. It was thought that the boulder skipped under a chain-link fence installed the day before. The fence was installed just below the ridge line, to keep similar smaller boulders from doing additional property damage downslope.

The grading contractor for the Burr Baldwin Jr. Inc. project is W. E. McKnight Construction of Baldwin Park. The project requires the movement of 780,000 cubic yards of earth to make room for 68 lots averaging 20,000 square feet.

Moral of the story...Caution and common sense consideration should be exercised during grading, or other construction operations in neighborhoods. As local realty prices continue to rise, development will occur in increasingly dangerous work areas. You may be responsible for property damage and much more seriously, loss of life.
